

PRIVACY POLICY

INTRODUCTION

Power of 32 (“Power of 32”, “we,” or “us,”) is strongly committed to respecting and protecting your privacy. Please carefully read the following Privacy Policy (“Policy”). In order to ensure your privacy, the information we collect from visitors to this Website (the “Site”) is used only in the manner and for the purposes described in this Policy.

The purpose of this Policy is to explain the type of information that Power of 32 collects, what we do with that information, and with whom we share this information. Once you have submitted an inquiry to us, we may communicate with you via mail, telephone, or email regarding your request to provide additional information related to your initial information request.
